Crossroads RV (Crossroads) has decided that a defect which relates to motor vehicle safety may exist in the vehicles listed above. As a result, Crossroads is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

It has been decided that certain Crossroads travel trailers have been built with defective Tru-Ryde or Axle Tek hubs on the axles. The wheel studs on hubs manufactured within a specified date code range may break causing wheel separation resulting in personal or property damage.

What we will do Crossroads will replace the defective hubs to remedy the situation. This will be done at no cost to you, the owner.

What we need you to do

At your earliest convenience, contact your servicing dealer to arrange an appointment to have your trailer inspected and repaired if needed.
